Dear members of the International Accounting Standards Board,


The Dutch Accounting Standards Board (DASB) appreciates the opportunity to respond to Exposure Draft 2017/2 Improvements to IFRS 8 Operating Segments.

We appreciate the efforts of the IASB to improve IFRS 8 and address issues identified in the post-implementation review of that standard. However, we are not convinced that the proposed amendments provide solutions for the issues that have been identified and we fear that the proposed amendments are likely to create new implementation questions upon their introduction. For those reasons we are not in favour of adding examples and additional guidance to the standards. We favour principle-based standards and accept that such standards require a certain level of judgement in practical application.

As a result we advise you not to proceed with these amendments to IFRS 8 and IAS 34.
